Geothermal court decision – Mammoth Pacific's geothermal power plant near the 395/203 junction was the first of its kind in 1984. In 2012, current operator Ormat proposed a replacement project to update the facility. Following extensive environmental, planning and reclamation review, permits approved by the Planning Commission and upheld by the Mono Supervisors on administrative appeal were challenged by an outside labor group on various claims, apparently employing "greenmail" tactics.

The Mono County Superior Court recently resolved the case in favor of Ormat and Mono County. Special thanks to Stacey Simon and the defense team of Barton Lounsbury and Antonio Rossman of Rossman & Moore, LLP, and Ormat's counsel James Reed of Liebersbach, Mohun, Carney and Reed for their successful defense, and Courtney Weiche, Gerry Le Francois, CD Ritter, Cedar Barager, Nick Criss and Dan Lyster for their supporting efforts.

Public Health

Flu Winding Down - It appears that we are in the last few weeks of the 2013-14 flu season, as activity continues to decrease nationwide.

That is good news, considering how severe this season has been compared to last year. So far, there have been 302 confirmed flu deaths in California, including 6 children. By this time last year, there were 34 deaths, with a total of 106 for the whole season. These severe outcomes remind us that flu can be a very serious disease for anyone.

Locally, we have not had any recent hospitalizations, and the numbers of positive flu tests and persons seen with flu-like illness is approaching baseline levels.



Prevent. Promote. Protect

The 2009 H1N1 "swine flu" continues to be the most common strain. This is significant, because it causes severe disease and death among a population not usually considered at highest risk. More than 60% of hospitalizations have been in persons age 18-64. Younger adults and children, especially those with chronic medical conditions were hit hardest. Others, such as pregnant females, those morbidly obese, and American Indians, were also hit hard.

It is unfortunate that this group of younger adults, especially those who are otherwise healthy, are less likely to get vaccinated. Although the rates for those >65 and children are usually over 60%, only about 34% of this group of individuals is vaccinated.

If you have not been vaccinated, you can still do so. Even more important is to make a decision now to get vaccinated when flu vaccine becomes available next fall. The strains for the vaccine have already been selected, and production is underway. There is talk of a possible new vaccine patch becoming available in addition to the shot and nasal spray. Stay tuned for more details!

As the flu winds down, there are still many sick in our communities with other bugs, such as norovirus and RSV (respiratory syncitial virus). The usual precautions apply:

- Stay home, and keep your kids home, when you/they are sick
- Wash your hands frequently
- Cover your cough
- Seek medical care if you are sicker than usual or have chronic medical conditions

Sheriff's Office

1. Jennifer Hansen held her quarterly meeting of the PIO Core Group for both Mono and Inyo Counties on Wednesday. We had multiple attendees and Jennifer put them through a simulated crisis scenario(s) to facilitate open discussion about "what if's". Jennifer received a very positive comment by one of the attendees stating: "Great meeting yesterday. Mono County is very lucky to have you and your skill set. I think we all learned something from your scenarios yesterday."

2. Sheriff Obenberger and staff met with Mineral County, Nevada, Sheriff Stewart Handte and his undersheriff, discussing topics such as budgets, staffing, radio communications, CAD systems, and much more.

3. Jail Staff discovered the jail building (D-Block area) had developed a hole in the outer stucco near the roof line. This allowed snow/rain water to penetrate the exterior of the building, causing damage to the interior of D-Block. **Thanks to the great Public Works staff** who have already fabricated a piece of sheet metal to divert the water away from building. They are working with jail staff to dry out the interior of the building's wall itself which could take some time. None of this however is hindering the ability to house our jail population.

4. Deputy Nino Hernandez, our School Resource Deputy, is again working with the local schools as the Sheriff's Office, and possibly the CHP office, will be participating in several fundraising basketball games against both Coleville High School and Lee Vining High School students. The games are tentatively set for <u>Saturday March 29th</u> @ 5:00pm (Coleville) and <u>Saturday April 5th</u> @ TBD (Lee Vining). We invite everyone to come see the games and support the local students.

5. Sgt. Beard held his quarterly Unified Command meeting for various first responders, county, town and state agencies, along with others groups. We had a very nice showing with apart 40 attendees (very nice attendance by State OES). No significant issues are at hand at this time.
