PROPOSED RECLAMATION PLAN AMENDMENT  
BLACK POINT CINDER MINE (CA MINE ID: #91-26-0001)

Dear Nick Criss:

The Department of Conservation's Division of Mine Reclamation (Division) received a complete submittal for the Black Point Cinder Mine from the County of Mono (County) on February 15, 2022. The County is the lead agency under the Surface Mining and Reclamation Act of 1975 (SMARA; Public Resources Code (PRC) Section 2710 et seq.). This mine is operated by Sierra Aggregates CO. Inc.

SMARA and associated regulations (California Code of Regulations Title 14, Division 2, Chapter 8, Subchapter 1, Articles 1 and 9) require that specific items be addressed or included in reclamation plans. Pursuant to PRC Section 2772.1 (b)(2), Division staff has reviewed the proposed reclamation plan amendment and associated documents in the administrative files and provides no specific comments at this time.

The Division looks forward to receiving a 30-day notice that the County intends to approve the reclamation plan. If you have any questions, please contact me at (916) 323-9198.
